Exhibit Booth Information

Standard booths are 10 x 10. **There is an additional charge of \$200 for each corner booth.** Additional charges for custom configuration will apply. Space assigned when application, deposit and contract approved by ASNT.

First booth includes an electronic lead retrieval system. Additional retrieval rentals available. ASNT reserves the right to change location assignments at any time, as it may deem necessary.

Payment Procedure

Application cannot be processed or space assigned without the required deposit (due with contract). Make all checks payable to American Society for Nondestructive Testing, Inc. Deposit shall be \$500 per booth 10'x10' space rented. Full payment is due **June 23, 2014**. Credit card payment is acceptable.

The \$500 deposit per booth is non-refundable.

Contract Terms

General

Upon acceptance of this contract by the American Society for Nondestructive Testing, Inc. hereinafter referred to as SOCIETY, the undersigned, hereinafter referred to as EXHIBITOR, agrees to the following SOCIETY policies:

The Exhibitor agrees to abide by the ASNT Display Rules & Regulations and all other rules as may be assigned by the Society.

Space Assignments

The Society shall use its best efforts to assign the booth designated by Exhibitor on the front side hereof, to provide physical separation of the booth from the booths of those competitors from whom Exhibitor has requested such separations on the front hereof. Notwithstanding the above, the Society reserves the right to change location assignments at any time, as it may in its sole discretion deem necessary.

Any and all matters or questions not specifically covered by the appended rules governing the ASNT Fall Conference shall be subject solely to the decision of the Society. All amendments (except booth rental prices) so made shall be binding on Exhibitors equally with the foregoing rules.

Exhibitor agrees to prepare an exhibit of its products or services, which shall be directly pertinent to the function or industry represented by the exposition specified, and as approved by the Society for display.

If the Society is prevented from holding the exposition or having commenced the exposition and thereafter is precluded from continuing it, due to acts of God, fires, strikes, or any other causes beyond its control, proportionate refunds of the rent paid may be made to the Exhibitor. Upon payment of the proportionate refunds (which amount shall be determined by Society), Society shall have no further obligation or liability to the Exhibitor. If Exhibitor had not made its rental payment, it is still obligated to pay its proportionate share of such rent.

Indemnification

Exhibitor agrees to protect, indemnify, defend, and save harmless the Society, the Headquarters Hotel, and exhibit facility (if other than the Headquarters Hotel), its employees and agents against any public liability, fines, imposed by governmental agencies, including court costs and attorneys' fees, which may arise or accrue by reason of the use by the Exhibitor of the rented space, its installation, removal and/or maintenance of all or part thereof. The exhibitor agrees to indemnify and release ASNT from responsibility for any loss, property damage, or personal injury that may occur to the exhibitor, exhibitor's employees, independent contractors, or persons using exhibitors' equipment, the exhibitor is liable for all and any damage.

Exhibitor acknowledges that the Society, the Headquarters Hotel and exhibit facility do not maintain insurance covering Exhibitor's property and that it is the sole responsibility of Exhibitor to obtain business interruption and property damage insurance covering such losses by Exhibitor. The Exhibitor shall obtain and keep in force during the term of the installation, use and dismantling of the rented space, policies of Comprehensive General Liability Insurance insuring and specifically referring to the contractual liability set forth in this, in an amount not less than \$1,000,000 combined single limit for personal injury and property damage. The Society, the Headquarters Hotel and/or exhibit facility shall be included in such policies as additional named insured's.

Cancellation Policy

The Exhibitor shall give notice of intention, in writing, to cancel or withdraw from the ASNT Fall Conference. If written notice is received prior to **June 23, 2014** full payment (if paid by Exhibitor) less deposit for each booth space reserved will be returned. No refund whatsoever will be made after **June 23, 2014**. In the event that said written notice is received after the **June 23, 2014** deadline, the Exhibitor is obligated for 100% of the total cost of the exhibit space in accordance with the terms of the agreement. The Society reserves the right to use such canceled space at its discretion.
